4. ALL VENDORS – FEES FOR BOOTH SPACE

*Booth space will be assigned to you by the Market Manger

*Fees will be collected on the market day by the Market Manager.

*After selling at the market for four times in one year a membership fee for each vendor of \$25.00 is due.

1 SUNDAY PAID WEEKLY:

- 5x5-foot space = \$20.00
- 10X10-foot space = \$30.00
- 20x10-foot space = \$50.00
- 30x10-foot space = \$65.00

4 SUNDAYS PAID MONTHLY:

- 5x5-foot space = \$75.00
- 10x10-foot space = \$100.00
- 20x10-foot space = \$160.00
- 30x10-foot space = \$200.00
